The Catholic Diocese of Kitui is pleased to announce the extension of tender submission deadline from, 30<sup>th</sup> March 2023, 10.30 AM to **11<sup>th</sup> April 2023 at 2:00 PM.** Tenders shall be opened on the same day (**11<sup>th</sup> April 2023 at 2:15 PM**) immediately thereafter, in the presence of applicants' representatives who choose to attend at the St. Joseph Mukasa Block Board Room. (Please note that tenders delivered after the just-stated closure shall not be accepted).

Applications from Interested and eligible Suppliers, Service Providers, Contractors, and Consultants are therefore invited for the supply and delivery of goods, provision of services, and works to the Catholic Diocese of Kitui, on '**as and when required**' basis for the year 2023.

Interested bidders are expected to **pay a registration fee of KSHs 2000, per Tender**, by way of **Cash deposit ONLY**, at the **National Bank of Kenya (NBK), CATHOLIC DIOCESE OF KITUI PROJECT A/C, A/C number; 01020075720000, Branch; Kitui** and **attach the cash deposit slip** on the tender document and seal **before** handing it in. **A single application is required per tender category and not per collective requirements A, B, and C (goods, services, and works) category.** (Those who wish to be considered for pre-qualification in more than one category should submit separate applications per tender category).

Completed tender documents should be **sealed** in a plain envelope **and clearly marked** with the
